- c. Any notes of Special Agents Shall and/or Bevington pertaining to conversations with this source;
- d. Any documents or reports relating to a follow-up investigation of the source's information conducted by any employee of the Dept. of Justice;
- e. Any documents memorializing whether anyone from the Dept. of Justice asked Kevin Weeks about the source's allegations and any documents memorializing his response;
- f. Any documents memorializing whether anyone from the Dept. of Justice asked John Martorano about the source's allegations and any documents memorializing his response;
- g. The identity of the girlfriend of Kevin Weeks referenced in the report; and,
- h. An unredacted copy of the 302 report.

5.
