#### **RE:** Disclosure and Matters of Confidentiality

Dear Attorneys Travers and Murray:

The undersigned write on behalf of the Estate of Aaron Hernandez, and Shayanna J. Jenkins Hernandez and Avielle Hernandez, individually and collectively for purposes of this letter "the family."

On April 19, 2017, Mr. Hernandez was discovered deceased in his cell at the Souza-Baranowski Correctional Center in Shirley, Massachusetts. Your offices conducted an investigation in conjunction with various state agencies into the death of Mr. Hernandez and have characterized his death as a suicide.

Pursuant to your investigation, you obtained various personal effects and writings from Mr. Hernandez's cell including writings made by Mr. Hernandez. It is our understanding that the state police, correctional officials and the medical examiner all have had access to the same personal effects and writings you obtained.

We are cognizant that the examination of <u>certain</u> of these personal effects and writings were relevant to your investigation into the circumstances of Mr. Hernandez's death. Notwithstanding the relevancy of any such personal effects and writings to your investigation, the family has an absolute right to privacy in all personal property and writings during and after the investigation.

Unfortunately, snippets of the contents of these notes and the findings of the investigation have been leaked to the press. Attached is a small sample of information in the public domain attributed to officials associated with your agencies. Although most of the leaked information is false, the media credits such information because the leaks come

from individuals with positions in government and law enforcement who are under your control.

Individuals within the government who are leaking such information are in violation of the policies and procedures of their respective agencies and should be immediately terminated. In addition, such individuals and agencies under your custody and control are violating the law, including, but not limited to:

## 1) General Laws chapter 214 section 1b:

"A person shall have a right against unreasonable, substantial or serious interference with his privacy. The superior court shall have jurisdiction in equity to enforce such right and in connection therewith to award damages."

### 2) MASS G.L. c. 268 Section 6A: False written reports by public officers or employees:

"Whoever, being an officer or employee of the commonwealth or of any political subdivision thereof or of any authority created by the general court, in the course of his official duties executes, files or publishes any false written report, minutes or statement, knowing the same to be false in a material matter, **shall be punished by a fine of not more than one thousand dollars or by imprisonment for not more than one year, or by both such fine and imprisonment** (emphases added).

(c) The record, document, or other object need not be admissible in evidence or free of a claim of privilege.

(d) A prosecution under this section may be brought in the county where the official proceeding was or would have been convened or where the alleged conduct constituting an offense occurred."

# **3) MASS G.L. c. 268A: CONDUCT OF PUBLIC OFFICIALS AND EMPLOYEES: Section 23: Supplemental provisions; standards of conduct:**

"Section 23. (a) In addition to the other provisions of this chapter, and in supplement thereto, standards of conduct, as hereinafter set forth, are hereby established for all state, county, and municipal employees.

(2) improperly disclose materials or data within the exemptions to the definition of public records as defined by section seven of chapter four, and were acquired by him in the course of his official duties nor use such information to further his personal interest.

[...]

(e) Where a current employee is found to have violated the provisions of this section, appropriate administrative action as is warranted may also be taken by the appropriate

constitutional officer, by the head of a state, county or municipal agency. Nothing in this section shall preclude any such constitutional officer or head of such agency from establishing and enforcing additional standards of conduct. "

# 4) General Laws chapter 258b section 3 grants victims the right to request confidentiality in the criminal justice system:

"To provide victims a meaningful role in the criminal justice system, victims and witnesses of crime, or in the event the victim is deceased, the family members of the victim, shall be afforded the following basic and fundamental rights, to the greatest extent possible [....]

(h) for victims and witnesses, to be informed of the right to request confidentiality in the criminal justice system. Upon the court's approval of such request, no law enforcement agency, prosecutor, defense counsel, or parole, probation or corrections official may disclose or state in open court, except among themselves, ... The court may enter such other orders or conditions to maintain limited disclosure of the information as it deems appropriate to protect the privacy and safety of victims, victims' family members and witnesses [...]"

Notwithstanding our repeated requests for your agencies to cease and desist, the dissemination of Mr. Hernandez's personal information and writings continues to cause the family severe emotional distress during an already difficult period.

We ask your respective agencies, agents, and employees to cease providing Mr. Hernandez's confidential information to the press and from leaking erroneous and harmful information. To the extent that you continue sharing such information with members of the press, we will pursue any and all remedies to protect our clients from further harm.

We are available at any time to meet with you to discuss the information you intend to publically disclose in an effort to accommodate your responsibilities while also considering with our clients' legal right to privacy.

Finally, we are aware that you have in your possessions writings by Mr. Hernandez addressed to his attorneys dated prior to the date of his death. The estate has not waived its privilege with respect to such communications. See <u>Matter of John Doe Grand Jury</u> <u>Investigation</u>, 408 Mass 480, 482-83 (1990) (stating that the attorney-client privilege survives the death of a client). To remedy your violation of the attorney-client privilege, we hereby demand that the originals of such communications be provided to the defense team, and any and all copies of such writings within your custody or control be accounted for and destroyed.

Please notify this office in writing that you have complied with our requests. The family appreciates your immediate attention to these matters.
