I have been here over a month and have no yard rec, \$30 canteen, no gym etc. So I wanted to tell some ways that may make it easier to get me to P2 "where I want and need to get to", not P1 like they've been telling me. And I know I really can't be bunked or as of I heard because people could easily steal my shirt, letters, law paperwork and sell it and could do anything to get money and publicity which will continue to kill my cases. Like media has already done. But there are two people I know from the streets who I'm close with; I will bunk up with them because I actually could trust them not to do that type shit. And they are both either on P2 or on their way there: [REDACTED] who I'd want to bunk with in P2 if I can get up there asap; or would even bunk with [REDACTED] when he goes up there. I'm not trying to go to P1, I need to be in P2 and start my bid. I'm doing "life", I want to get where I'm actually going to be for the long haul which will be P2. I have no enemies so should be an easy move. Yes, I would like a single because anyone could try some funny shit with my belongings that would hurt my case but those two I wouldn't mind ceiling up with. Please get back to me and hopefully we can get this done so I can finally get comfortable and start my bid and be placed where I belong. I'm pleading with you to get up there WHERE I BELONG! I hope this can be done shortly, I'd really appreciate it. I know many inmates get placed where they feel... or KNOW they belong, so I hope I can as well. I'm only asking to be treated like a regular inmate to the fact of being where I belong which is P2 but I am not oblivious to the fact of having to be careful because everything can blow up in media or whatever but I'ma tell y'all that its by far the best, safest move for me and all of us where everything will be smooth. my bid and be a regular inmate, get comfortable on the block I'll eventually be for long haul once im there and get everything started! Thanks again for your time!


P.S. Please make this happen!
