RE: Inmate Aaron Hernandez

Be advised the schedule below will be followed for Inmate Aaron Hernandez while he is housed in ED Unit. Please note that Inmate Hernandez will not be on any type of Special Management Status and will therefore be allowed to order commissary items weekly as well as have unit recreation without restraints daily. Inmate Hernandez, when he exits the unit for any reason, he will go without restraints and **MUST** be escorted.

SCHEDULE

- 9-10 am: Unit Recreation, inmate will be allowed to utilize the phone and shower in the unit.
- 1-2 pm: Unit Recreation, inmate will be allowed to utilize the phone and shower in the unit.
- 3:15 - 4:15pm: Outside Recreation, inmate will utilize the EE Unit Recreation Yard (Not the Rec Pen). Inmate is to be exercised alone and can go to and from the Recreation Yard without restraints and **MUST** be escorted to and from the ED Unit by security staff.

(If inmate has recreation later than 4:30 pm the Recreation Pen **WILL** be utilized due to darkness and for security reasons). Inmate will be allowed to shave in the Property Room prior to exiting the facility for court daily Monday through Friday. **NO RAZORS WILL BE ALLOWED IN ED UNIT.** Inmate can utilize electric shaver in unit if requested.

- 7:30-8:30 pm: Unit Recreation, inmate will be allowed to utilize the phone and shower in the unit.

All of this inmates activity mentioned above (Phone usage, exercise, showers, etc...) will be, documented on this inmates Special Housing Unit Form as well as in the ED Unit Logbook.

Anytime another Inmate needs to exit their cell, or needs to enter / exit the ED unit, Inmate Hernandez **MUST** be secured within his cell before the other Inmate is allowed to exit his cell or is allowed to enter ED. The ED unit must be clear, and all Inmates secured in their cells **BEFORE** Inmate Hernandez is allowed back out of his cell.

ANYTIME INMATE HERNANDEZ NEEDS TO BE SECURED BACK IN HIS CELL FOR AN INMATE TO EXIT FROM THEIR CELL AND/OR UNIT, OR FOR ANY INMATE THAT NEEDS TO ENTER THE ED UNIT, THIS TIME WILL **NOT** BE DEDUCTED FROM INMATE HERNANDEZ' 1 HOUR RECREATION. INMATE HERNANDEZ WILL GET A FULL HOUR RECREATION.
